Locality Pay lawsuit update

On June 22, 2005, federal employees in Hawaii and Alaska filed a class action lawsuit in the U.S. District Court in Hawaii against the Federal Government challenging "locality pay" policies that unfairly and irrationally discriminate against Federal employees who work and reside in Hawaii and Alaska. The lawsuit seeks locality pay for federal employees who work in those jurisdictions. Lead counsel in the case are Greg McGillivary of Woodley & McGillivary, and Margery Bronster of the Honolulu law firm of Bronster, Crabtree & Hoshibata. The Honorable Chief Judge Philip M. Pro of the U.S. District Court of Nevada is presiding over the case. The lawsuit does not affect the cost of living allowance (COLA) payments

<u>CASE STATUS</u> On January 4, 2007, Judge Pro certified the case as a class action. There are two classes:

- (1) All persons employed by the United States in the contiguous 48 states who receive locality pay; and
- (2) All employees of the United States who are ineligible to receive locality pay since they are employed in Hawaii or Alaska.

Also on January 4, 2007, Judge Pro granted the plaintiffs' motion (e.g., document requests, interrogatories, etc.) to conduct discovery. The Government had opposed plaintiffs' attempt to conduct discovery. Discovery will continue for 120 days. At the Completion of discovery, the parties will brief the issue of the Government's liability.

The Government moved to dismiss the lawsuit or, in the alternative, to transfer the case to the Court of Federal Claims. On February 21, 2006, The Honorable Judge Philip Pro denied the Government's motion with respect to the claims concerning locality pay.

Judge Pro also determined that claims that COLA should be included in retirement pay calculations must be pursued through the Merit Systems Protection Board (MSPB). Although the Government appealed the decision - thereby delaying the case for five months - it has now decided to drop its appeal. On July 14, 2006, the Government filed its Answer.
