
At the congressional level we have been working with our National FMA office on major issues. Some of them include:

- (1) Having congress avoid enacting sweeping, across-the-board federal workforce cuts.
- (2) Having congress avoid restricting federal agencies by relying on continuing resolutions to fund federal operations, and all appropriations bills should be passed in a timely manner.
- (3) Having congress end the current pay freeze and should restore the practice of evaluating civil service pay adjustments on a yearly basis.
- (4) Congress should not attempt to balance the federal budget through decreases to federal employee pay and benefits.

At the National FMA convention this year in Washington D.C. we had a great opportunity to visit and lobby with our congressional senators. One of the important take aways from our discussion with Senator Inouye was that we should always be concerned about the BRAC. Pearl Harbor will always be considered for base closure.

The executive board and I look forward to serving you and welcome ideas you may have to improve our service to you.
